Board of Directors' Meeting - Friday May 11, 2012

The national board of directors' meeting will be held in the Boardroom in the Hotel 2.00-5.00 pm.

Dan Examination - Friday May 11, 2012

The dan examination will be held in the Hotel, from 6:00 to 7:00 pm. The examination will be administered by Okazaki Sensei, 10th Dan, and Yaguchi Sensei, 9th Dan. Registration procedures are as follows:

- Two copies of the registration form must be submitted in type by May 1, 2012, with two passport photographs along with the dan examination fee as per the fee schedule on page 8. The form must also be signed in the permission section by the Provincial Chief Instructor.
 - If successful, dan registration fees, (which is not included in the testing fee) must be submitted to the National Office within one month by the Provincial Director.
- Please include a copy of your rank record.

Judges Clinic and Examinations - Friday May 11, 2012

There will be a **judges' training clinic** on Friday May 11, from 6:00 to 7:00 pm in the **Hotel**. The cost for the clinic is **\$20.00**. Clinic is open to all Judges, and is recommended. The ISKF International Judge Examination is in two parts – written exam and practical exam. The cost of the written and practical examination is **\$80.00**. The judge's written exam and practical exam will be held in the hotel from 7:00 – 10:00 pm (directly after the judges training clinic). Pre-requisites for these exams are twenty-two years of age, and a minimum of second dan. The registration form must be completed by the registration deadline. Examinees must have their own whistle and be in their gi.

- If successful, judge's registration fees, (which is not included in the testing fee) must be submitted to the National Office within one month by the Provincial Director.
